



## 2023 RACE-MANIA SUMMIT AND EXPO GRAND PRIZE DETAILS

### A. OVERVIEW

There will be two Grand Prize giveaways at the 2023 RACE-MANIA Summit and Expo:

1. **Grand Prize #1:** 2024 Challenge Roth 7-Night Classic Race Week Tour with one race entry (value \$3,995).
2. **Grand Prize #2:** 2023 Kona World Championship 7-Night Tour for you and a guest (value: \$5,995)



**Grand Prize Package #1:** 2024 Challenge Roth 7-Night Classic Race Week Tour with one race entry

**Prize Value:** \$3,995

**Package Dates:** Tuesday, July 2 through Tuesday, July 9, 2024. Race day is July 7, 2024.

This prize package includes access to a coveted 2024 Challenge Roth (Germany) individual race entry (\$695 value), AND a 7-Night Classic Race Week Tour that includes the following services and amenities:

- Round-trip transportation for Munich airport and our hotel

### **IMPORTANT INSTRUCTIONS FOR THE WINNERS**

The *2024 Challenge Roth Grand Prize Package* and the *2023 Kona World Championship Grand Prize Package* at Race-Mania must be used in the year they are designated, or they are considered forfeited. Prize packages cannot be exchanged, transferred or gifted to another traveler. For Challenge Roth 2024, the deadline to use your race entry code and register yourself into the race is September 30, 2023. If you fail to register by the deadline, you forfeit the race entry and may join the tour as a spectator. If you do not intend to race the event, we welcome you as a spectator on tour. You may also choose to upgrade your Challenge Roth prize package from the Classic tour in Nuremberg to the Finish Line Tour in Roth, for an additional fee. (Based on availability.) The contest is not open to any employee, vendor or tour partner associated with RaceQuest.
